Howell Town's Subdivision Ordinance Amendment

In 2023 the state legislature passed some bills that required the town's subdivision ordinance be amended. The legislature also provided funding for amending the town's subdivision ordinance. Howell Town is working through the Hansen Planning Group. They have reviewed the town's subdivision ordinance and made recommendations on how our subdivision ordinance should be amended. In reading their recommendations there were some concerns raised. Mayor Brad Hawkes is going to call the Hansen Planning Group to get clarification on what they recommended.

Mayor, Council Member Reports

Mayor Brad Hawkes:

• We need to investigate selling the generator in the 1977 well pump house.

Council Member Rex Nessen:

- The air conditioning unit in the road grader needed repairs.
- The road grader needs new tires.
- On 18000 West near the Hereford Canyon bridge a new larger culvert needs to be installed.
- The smaller cement bridge in the same area needs to cleaned out and a new top put on.
- The slurry seal for the oiled roads is \$50,000.00 per mile. It was decided to do the oiled portion of 14400 West.

Council Member Josh Anderson: Not Present

Council Member Craig Hawkes:

When the chlorinator was installed, it was suggested that instead of using the liquid form
of chlorine instead of the gas form. It is safer to use and would not require an outside
shed.
