From the August Town Council Meeting

Sgt. Shane Braegger reported there were 16 incidents here in Howell and the surrounding area. Other A1c/Off not DUI/Pub intox 2; Citizen Assist 1; Community Policing 1; Extra Patrol 4; Assist Fire 1; Juvenile Problem not runaway 1; Assist Medical 1; Motorist Assist 2; Traffic Accident no injury 1. VIN Number Inspection 2.

At 7:10 p.m. the town council held a public hearing to get put input on amending the FY2024 budget.

Town Clerk H. Leon Kotter reported that we had received more revenue than was budgeted for in the general fund. It was a conservable amount. Also, the capital Projects fund expenditures were less than what was budgeted.

Our town treasurer, Shelly Logan, gave a financial report for July. We are still well within our budget.

There is a vacancy in the town's planning commission. Mayor Brad Hawkes reported that three town residents expressed interest in becoming a member of the Howell Town Planning Commission: Jason Mauchley; Jennifer Rose and Arthur Douglas. Mayor Hawkes had the names listed on slips of paper. Each council member was given one of the slips. They were to vote for one of the candidates. Jason Mauchley received the most votes.

Resolution R24-05 amending the FY2024 budget was presented. There was no further discussion. The General Fund was amended from \$228,503.00 to \$234,231.00 and the Capital Project Fund from \$23,358.00 to \$13,913.00. In 2023 the state legislature passed some bills that required the towns across the state to amend their subdivision ordinances. The legislature also provided funding for amending these subdivision ordinances. Howell Town is working through the Hansen Planning Group. They have reviewed the town's subdivision ordinance and made recommendations on how our subdivision ordinance should be amended. In reading their recommendations there were some concerns raised. Mayor Brad Hawkes is going to call the Hansen Planning Group to get clarification on what they recommended.

From the Mayor, Council and Clerk reports: Mayor Hawkes suggested that we sell the generator in the 1977 well pump house. We do not use it. It is just sitting there.

Council Member Rex Nessen reported that the air conditioning unit on the road grader has been repaired. Also, the road grader needs new tires.

On 18000 West north of the Hereford Canyon bridge a new larger culvert needs to be installed to handle the run-off water. The smaller cement bridge in the same area needs to be cleaned out and a new top put on.

Darin MacFarland, Box Elder County Road Supervisor, came out and went over our roads. The oiled roads are in decent shape except for the oiled portion on 14400 North. There is a slurry seal that works well but is expensive at \$50K per mile. The oiled portion on 14400 North is half mile in length. It was decided to do that oiled portion.

Council Member Craig Hawkes reported that when the chlorinator was installed it was suggested that we use the liquid form of chlorine rather than the gas form. It is safer and does not require an outside shed.

Town Clerk Leon Kotter presented his idea about the town's newsletter no longer being included with the water/garbage bill. It is available on the town's website: howelltown.org. There are some who do not have internet access and they will receive a copy with their water bill. This was in the July newsletter.
